I was not a member of the Nazi party. Membership in "minor" organizations, such as the N.S.K.K. (National Socialist Motorist Corps), N.S. Altherrenbund (Alumni organization), N.S.-Luftschutzbund (Air Road Defense Organization), and N.S.V. (Winter Relief Organization) was therefore required to obtain a higher academic degree at that time. When I moved to Riems in 1942 I resigned from the N.S.K.K.

Files of the Bureau reflect that Eric Traub is a German Specialist who has been brought to the United States under the protective custody of the Joint Intelligence Agency. Reference is made to my memorandum to you dated March 23, 1949, concerning other scientists on whom loyalty forms were received. It will be recalled that upon discussing the confidential nature of the work of these scientists and the fact that they are more or less under the protective custody of the Joint Intelligence Agency, the Navy advised that forms on such scientists were sent to the Bureau by mistake and should be returned to the Navy Department by Liaison.
